Funds open in Round 1 2017/18 Deadline 5pm, Friday 5th May 2017

For your information, here is a list of the funds that will be open in Round 1 2017/18, and the areas that the donors in each case are interested in supporting. Please check our website for further information about applying and new funds available.

For the most part, you DO NOT need to apply to a particular fund – please put your application on our general application form, available at www.sussexgiving.org.uk/apply. We will put your application to the fund we think most likely to fund your application. However, some funds do have their own criteria and/or application forms, as noted below – please see our website for these.

Alta Fund Grants to charities and community groups in Sussex (excluding Brighton & Hove) which support young people; promote education and achievement; help children who are disadvantaged; use the arts to support disadvantaged people. Preference is for the areas around Uckfield, East Grinstead and Lewes. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Amy Hart Fund Grants to charities and community organisations across East Sussex that offer support and services for people in need, hardship or distress. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Anjoli Stewart Fund Grants to support smaller charities and community groups working in Hastings and the surrounding area, addressing disadvantage and helping people who have few choices in life to address their own problems and achieve their potential. The donors are keen to pump-prime new ideas and projects. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Brenda Ford Fund Grants to support community grassroots groups and charities working in Sussex, offering advice, support and services to women at risk of, or in situations of, domestic abuse. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Comic Relief Community Cash Grants will be used to support work where there is clear evidence of a beneficial impact on people's lives particularly those who are excluded or disadvantaged through low income, rural or social isolation, age, disabilities, race, sexuality or gender. Grants of £500-£1,000 are available to small organisations in Sussex. Separate guidance and application form.

Cragwood Fund – large grant programme Supporting charities and community groups of all sizes which support homeless and/or vulnerably housed people in West Sussex, especially new or extended programmes of work in: preparing for work and the cultivation of skills for employment; training and support around money, health and well-being and the practical skills associated with independent living; social reintegration and resilience in preparation for independent living. One grant of up to £20,000 per year for a period of three years. Separate guidance but please apply using the standard Sussex Community Foundation application form.

Cragwood Fund – small grants Supporting charities and community groups addressing disadvantage, with a focus on older people and a preference for those working in West Sussex. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Cullum Family Fund Grants to charities and community groups operating in Brighton & Hove and West Sussex and working with issues around homelessness; supporting children, older people, and people with learning disabilities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

East Brighton Trust Fund Grants to charities, community and voluntary groups undertaking projects or events that benefit people who live in East Brighton. Grants up to £500. Separate guidance and application form.

Ganas Fund Supports charities and community groups addressing disadvantage across Sussex, with preference with Brighton & Hove. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Dame Elizabeth Nash Fund Grants to small charities and community groups supporting those in need in rural West Sussex, particularly the parishes of Walberton, Bury, Boxgrove and Bosham. Grants of up to £2,000. Standard Sussex Community Foundation application form.

Fairfield Fund Grants to support groups working across East Sussex and Brighton & Hove, particularly in the Hastings and Rother districts. Groups can include those working in the following areas: children & young people; assistance for the disabled or learning disabled; literacy & language and those working to address disadvantage. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Frank & Lorna Dunphy Fund Grants to smaller charities and community groups working to address disadvantage in Bognor Regis and the surrounding area, including homelessness, mental health, domestic abuse, drug and alcohol problems or support for children or young people to reach their potential. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Gatwick Foundation Fund Grants to charities and community groups in Horsham, Mid Sussex, Crawley and Wealden districts with projects helping people to gain confidence and raise aspirations through training and development of new skills; addressing social isolation and disadvantage experienced by families, children and older people; helping young people widen their horizons and aspirations. Grants of up to £10,000. Standard Sussex Community Foundation application form.

Gurney Charitable Trust Grants to smaller charities and community groups in Sussex which address a range of charitable causes including health and medical issues, disability and disadvantage, natural history and the arts. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Ian Askew Charitable Trust Fund Supporting charities and not-for-profit organisations across Sussex which provide a 'leg up' as opposed to a 'hand out', working in the following areas: education; health; welfare of children; housing needs; job creation and sustainability; mental health; substance misuse. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Lawson Endowment supports charities and community groups in Sussex (particularly in the north of East Sussex), including those working in the following areas: older people; health issues; children and young people; assistance for the disabled or disadvantaged; arts and culture. Grants of up to £5,000 are made. Standard Sussex Community Foundation application form.

Madeleine Fund Grants to charities and community groups across Sussex which enable young people to experience or participate in the arts, with a particular focus on young people who wouldn't normally have these opportunities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Marit & Hans Rausing Fund Grants to charities and community groups working in Sussex and seeking to address the root causes of social and economic disadvantage and deprivation. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Nick & Gill Wills Fund Grants to charities and community groups in Sussex supporting women who are vulnerable or at risk of abuse, exploitation or violence; promoting women's rights or equality between men and women. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Rooney Foundation Fund Grants to grassroots charities and community groups in Sussex working with, and supporting, children with special needs and their families. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Peter Baldwin & Lisbet Rausing Fund Grants to charities and community groups across Sussex providing end-of-life care and supporting people affected by terminal illness. Applicants must have a turnover of less than £1 million per annum. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Sachs Trust Fund Grants to charities and community groups in Lewes and within a ten-mile radius of the town. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Selits Fund Grants to support projects within Brighton & Hove which address homelessness or help provide better opportunities for disadvantaged children and young people. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Sussex Giving Fund Grants to small charities and community groups in Sussex, working for the benefit of the community. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Westdene Fund Grants to individual young people (16-25 years) in Sussex with outstanding musical talent. Grants of up to £1,000. Separate guidance and application form.

Westoute Fund Grants to small charities and community groups involved in preventative work to minimise disadvantage, including in the fields of drug and alcohol rehabilitation, offending, mental health, young people and homelessness. Grants of up to £5,000. Standard Sussex Community Foundation application form.

William Reed Fund Grants to local or national organisations supporting social welfare projects operating and benefiting people in the Crawley area. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Worthing & Adur Fund Grants to small charities and community groups working in Worthing & Adur. Grants up to £1,000. Standard Sussex Community Foundation application form.
