



Sussex Community Foundation General Awards

Funds open in Round 2 2017/18 Deadline 5pm, Friday 15th September

For your information, here is a list of the funds that will be open in Round 2 2017/18, and the areas that the donors in each case are interested in supporting. Please check our website for further information about applying and new funds available.

For the most part, you DO NOT need to apply to a particular fund – please put your application on our general application form, available at www.sussexgiving.org.uk/apply. We will put your application to the fund we think most likely to fund your application. However, some funds do have their own criteria and/or application forms, as noted below – please see our website for these.

Aisbitt Family Fund Supports small charities and community groups across Sussex (but with a preference for Brighton & Hove) addressing disadvantage, with an emphasis on preventative work. The issues addressed may include: drug & alcohol addiction; mental health; young people, particularly those leaving care; homelessness; and domestic violence. Grants of up to £5,000. Standard Sussex Community Foundation application form

Alta Fund Supports charities and community groups in Sussex (excluding Brighton & Hove) which support young people; promote education and achievement; help children who are disadvantaged; use the arts to support disadvantaged people. Preference is for the areas around Uckfield, East Grinstead and Lewes. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Anjoli Stewart Fund Supports smaller charities and community groups working in Hastings and the surrounding area, addressing disadvantage and helping people who have few choices in life to address their own problems and achieve their potential. The donors are keen to pump-prime new ideas and projects. Grants of up to £5,000. Standard Sussex Community Foundation application form.

American Express Fund Supports charities working in Brighton & Hove and Burgess Hill, addressing one or more of the following: developing leadership in the non-profit sector; promoting volunteering and community engagement (including opportunities for AMEX employees); helping disadvantaged people into work; promoting diversity, social inclusion and equal rights, targeting groups such as Black and minority ethnic communities, women, Lesbian Gay Bisexual and Transgender communities and Hispanic communities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Arthur & Doreen Green Fund Supports small community groups and charities in Sussex, including hospices, young people and the elderly. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Arthur and Rosemary Kay Fund Supports charitable organisations that help disadvantaged people, particularly those helping families on low incomes, homeless people or people with disabilities across Sussex. Preference is for East Sussex. Grants of up to £2,000. Standard Sussex Community Foundation application form.

Beechlands Fund Supports young people and those in education with grants to provide a springboard to successful careers and rewarding lives. Sussex-wide but preference for projects near Lewes, including Brighton & Hove. Standard Sussex Community Foundation application form.

Brighton Rock Supports charities and community groups in Sussex working to benefit the environment, including addressing climate change; and work with older people. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Boltini Fund Supports community groups and charities addressing disadvantage in West Sussex, in particular the needs of children and young people, people with chronic illness and with disabilities, and people who are homeless. Grants of up to £5,000. Standard SCF application form.

Comic Relief – Core Strength Fund for Local Communities supports charitable organisations with annual incomes of up to £100,000 addressing disadvantage, to cover **core costs** (i.e. expenditure not connected to delivering projects but focussing on investing in the organisation as a whole, such as basic running costs). Grants of up to £10,000. This fund has its own criteria and online application form. Applicants may apply separately to both this fund and SCF general awards Round 2 provided that any application for the latter is to support project activity costs (i.e. **not** for core costs). Deadline 6th October 2017.

Cragwood Fund – large grant programme Supporting charities and community groups of all sizes which support homeless and/or vulnerably housed people in West Sussex, especially new or extended programmes of work in: preparing for work and the cultivation of skills for employment; training and support around money, health and well-being and the practical skills associated with independent living; social reintegration and resilience in preparation for independent living. One grant of up to £20,000 per year for a period of three years. Separate guidance but please apply using the standard Sussex Community Foundation application form.

Cragwood Fund – small grants Supports charities and community groups addressing disadvantage, with a focus on older people and a preference for those working in West Sussex. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Cullum Family Fund Supports charities and community groups operating in Brighton & Hove and West Sussex and working with issues around homelessness; supporting children, older

people, and people with learning disabilities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Dexam Fund Supports charitable organisations operating in West Sussex, particularly in the Midhurst and Petworth areas. Groups can include those working with issues around young people, elderly people, and needs in rural areas including environmental and countryside schemes. Grants of up to £5,000. Standard Sussex Community Foundation application form.

East Brighton Trust Fund Supports charities, community and voluntary groups undertaking projects or events that benefit people who live in East Brighton. Grants up to £500. Separate guidance and application form.

Fairfield Fund Grants Supports groups working across East Sussex and Brighton & Hove, particularly in the Hastings and Rother districts. Groups can include those working in the following areas: children & young people; assistance for the disabled or learning disabled; literacy & language and those working to address disadvantage. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Fangorn Fund Open to charities and community groups in any part of Sussex but with a preference for West Sussex, supporting a wide range of charitable causes with an emphasis on tackling disadvantage. Standard Sussex Community Foundation application form. Grants of up to £5,000.

Fleming Family Fund Supports small groups and charities working with children and older people across Sussex, especially those with disabilities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Gatwick Foundation Fund Supports charities and community groups in Horsham, Mid Sussex, Crawley and Wealden districts with projects helping people to gain confidence and raise aspirations through training and development of new skills; addressing social isolation and disadvantage experienced by families, children and older people; helping young people widen their horizons and aspirations. Grants of up to £10,000. Standard Sussex Community Foundation application form.

Ian Askew Charitable Trust Supports charities and not-for-profit organisations across Sussex which provide a 'leg up' as opposed to a 'hand out', working in the following areas: education; health; welfare of children; housing needs; job creation and sustainability; mental health; substance misuse. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Innes Fund Supports disadvantaged people and promoting well-being in West Sussex. Grants of up to £5,000. Standard Sussex Community Foundation application form.

John Laing Charitable Trust Supports charities and community groups in West Sussex which support homelessness, disadvantaged and exploited young people with a preference for prevention and early intervention, education (for those aged 3-18), and community regeneration including charities benefitting the aged. Grants of up to £1,000, and the

organisation should have a turnover of less than £300,000. Standard Sussex Community Foundation application form.

Lawson Endowment Supports charities and community groups in Sussex (particularly in the north of East Sussex), including those working in the following areas: older people; health issues; children and young people; assistance for the disabled or disadvantaged; arts and culture. Grants of up to £5,000 are made. Standard Sussex Community Foundation application form.

Lewes Fund Supports small local charities and community groups in Lewes area addressing disadvantage. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Little Cheyne Court Wind Farm Fund Supports Sussex charities and community groups who operate within ten miles of the wind farm which lies seven miles west of Lydd on Romney Marsh. Grants of between £500 and £5,000 support environmental, educational, community and charitable activities. This fund has its own guidance and application form. Deadline: Friday 22nd September.

Lorna's Fund Supports smaller charities and community groups working to address disadvantage in Bognor Regis and the surrounding area, including homelessness, mental health, domestic abuse, drug and alcohol problems or support for children or young people to reach their potential. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Madeleine Fund Grants to charities and community groups across Sussex which enable young people to experience or participate in the arts, with a particular focus on young people who wouldn't normally have these opportunities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Marit & Hans Rausing Fund Supports charities and community groups working in Sussex and seeking to address the root causes of social and economic disadvantage and deprivation. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Meads Fund Supports Eastbourne based charities addressing disadvantage and people and communities within Eastbourne. There are no restrictions on what you may apply for, except that we will not support capital projects. One grant of up to £20,000 is available for three years. This fund has its own criteria and application form.

Older and Bolder Fund Supports small charities and community groups working to reduce isolation among older people or people with mental health problems. Applications which include therapeutic contact with cats or other animals are encouraged and fun or quirky projects are also particularly welcome. Grants of up to £5,000. Standard SCF application form.

Open Door Fund Supports homeless and vulnerably housed people in West Sussex. There are no restrictions on what you may apply for, except that we will not support capital projects. One grant of £10,000 is available for three years. This fund has its own criteria and application fund.

Rooney Foundation Fund Supports grassroots charities and community groups in Sussex working with, and supporting, children with special needs and their families. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Rye Fund Supports charities and community groups operating in Rye and surrounding villages within a 9-kilometre radius. Grants of up to £1,500. This fund has its own criteria and application form.

Sussex Giving Fund Supports small charities and community groups in Sussex, working for the benefit of the community. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Westdene Fund Supports individual young people (16-25 years) in Sussex with outstanding musical talent. Grants of up to £800. Separate guidance and application form.

William Reed Fund Grants to local or national organisations supporting social welfare projects operating and benefiting people in the Crawley area. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Young People's Fund Supports grants to improve the life chances of young people in Sussex. Initially, there will be a preference for projects in East Sussex and Brighton & Hove. Grants of up to £5,000. Standard SCF application form.

Youth Social Action Fund Supports charities and community groups to engage young people in campaigning, volunteering, fundraising as part of a drive to encourage youth social action. This is part of the iwill campaign, funded by Department for Media, Culture and Sports and the Big Lottery Fund who each invested £20 million to transform the culture of community engagement by getting young people involved in greater volunteering opportunities. Grants of £1,000 - £5,000. This fund has its own criteria and application form.
