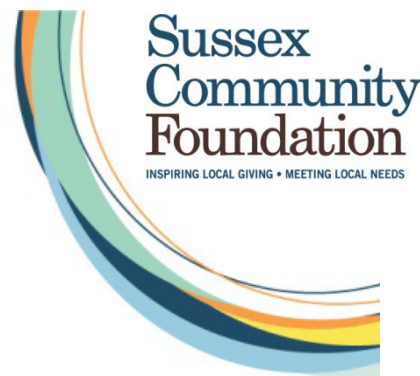


Fund Directory



Funds open in Spring Round 2018/19

Deadline 5pm, Friday 14th January

For your information, here is a list of the funds that will be open in Round 3 2018/19, and the areas that the donors in each case are interested in supporting. Please check our website for further information about applying and new funds available.

For the most part, you DO NOT need to apply to a particular fund – please put your application on our general application form, available at www.sussexgiving.org.uk/apply. We will put your application to the fund we think most likely to fund your application. However, some funds do have their own criteria and/or application forms, as noted below – please see our website for these.

Brighton and Hove Legacy Fund - Children & Young People Grants to not for profit organisations which support the educational and personal development of children and young people of Brighton & Hove. Grants of up to £5,000. Standard SCF application form.

Brenda Ford Fund Grants to support community grassroots groups and charities working in Sussex, offering advice, support and services to women at risk of, or in situations of, domestic abuse. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Brighton & Hove Arts Fund Small charities and community groups involved in the arts in Brighton & Hove. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Carpenter Box Fund To support small, local voluntary and community groups and organisations that are active in West Sussex and that are providing services within two broad charitable themes. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Cragwood Fund – small grants Supports charities and community groups addressing disadvantage, with a focus on older people and a preference for those working in West Sussex. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Cullum Family Trust Fund Grants to charities and community groups operating in Brighton & Hove and West Sussex and working with issues around homelessness; supporting children, older people, and people with learning disabilities. Grants of up to £5,000. Standard Sussex Community Foundation application form.

East Brighton Trust Fund Grants of up to £500 are available to not-for-profit organisations including charities, community and voluntary groups undertaking projects or events in East Brighton. This Fund has its own application form and guidance.

Field Family Fund Awards grants to small charities and community groups promoting good citizenship amongst young people in Sussex; providing support and activities for older people, to enable them to live life to the fullest; or involved in end of life care and bereavement support. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Gatwick Foundation Fund Grants to charities and community groups in Horsham, Mid Sussex, Crawley and Wealden districts with projects helping people to gain confidence and raise aspirations

through training and development of new skills; addressing social isolation and disadvantage experienced by families, children and older people; helping young people widen their horizons and aspirations. Grants of up to £10,000. Standard Sussex Community Foundation application form.

Ian Askew Charitable Trust Fund Supporting charities and not-for-profit organisations across Sussex working in the following areas: education; health; welfare of children; housing needs; job creation and sustainability; mental health; substance misuse. Grants of up to £1,000. Standard Sussex Community Foundation application form.

Innes Fund Supports disadvantaged people and promoting well-being in West Sussex. Grants of up to £5,000. Standard Sussex Community Foundation application form.

John Laing Charitable Trust Fund Grants for charities and community groups in West Sussex which support homelessness, disadvantaged and exploited young people with a preference for prevention and early intervention, education (for those aged 3-18), and community regeneration including charities benefitting the aged. Grants of up to £1,000, and the organisation should have a turnover of less than £300,000. Standard Sussex Community Foundation application form.

Kim Addison Fund Grants are to help disadvantaged children, for example by running activities or holidays they might otherwise be unable to afford. Grants generally round £500. Standard Sussex Community Foundation application form.

Knighton Fund The Knighton Fund supports charities and not-for-profit organisations across Sussex which support children and young people, with a particular focus on those in the Mid Sussex area. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Lawson Fund The Lawson Endowment supports charities and community groups in Sussex (particularly in the north of East Sussex), including those working in the following areas: older people; health issues; children and young people; assistance for the disabled or disadvantaged; arts and culture. Grants of up to £5,000 are made. Standard Sussex Community Foundation application form.

Lewes & District Flood & Disaster Relief Fund Small charities and community groups operating in Lewes District and addressing disadvantage. Grants of up to £5,000 are made. Standard Sussex Community Foundation application form.

Leyden House Fund Small community groups and charities in Sussex providing support and services for people with a disability. Grants of up to £5,000 are made. Standard Sussex Community Foundation application form.

Lisbet Rausing & Peter Baldwin End of Life Care Fund Grants to charities and community groups across Sussex providing end-of-life care and supporting people affected by terminal illness. Applicants must have a turnover of less than £1 million per annum. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Little Cheyne Court Wind Farm Fund Supports Sussex charities and community groups who operate within ten kilometres of the wind farm which lies seven miles west of Lydd on Romney Marsh. Grants of between £500 and £5,000 support environmental, educational, community and charitable activities. This fund has its own guidance and application form.

Lorna's Fund Supports smaller charities and community groups working to address disadvantage in Bognor Regis and the surrounding area, including homelessness, mental health, domestic abuse, drug and alcohol problems or support for children or young people to reach their potential. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Margaret Greenhough Fund Grants to not-for-profit organisations which promote music and arts in Sussex. Grants of around £1,000. Standard Sussex Community Foundation application form.

Marit And Hans Rausing Fund Charities/groups across Sussex addressing the root causes of disadvantage. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Millicent Mather Fund Supports small charities and community groups in West Sussex, particularly those involved in education and the arts. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Newhaven EZ Community Fund

Grants to support local charities and non-profit organisations to benefit Newhaven. The Fund aims to encourage a sense of place and to build on the thriving community in the town. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Price Family Fund Grants to charities and community groups in Mid Sussex supporting children and young people. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Rampion Fund Grants to support organisations working for the benefit of the people of Sussex from Littlehampton Harbour in the west, to Beachy Head in the east and up to the A272 near Twineham in the north close to the wind farm's onshore substation. Supports projects that benefit the broad community, in particular those with links to environment and ecology, climate change and energy, and improved community facilities. Grants of up to £50,000. This fund has its own criteria and application form.

Rooney Foundation Fund Grants to grassroots charities and community groups in Sussex working with, and supporting, children with special needs and their families. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Sierra Gorda Fund Supports small community groups and charities that address disadvantage and build stronger communities, or those working in the arts. It supports organisations working in East Sussex with a preference for those in Hastings, St Leonards and Rother district. Grants of up to £1,000. Standard Sussex Community Foundation Application Form.

Surviving Winter Fund Supports community and voluntary groups working with people facing fuel poverty to stay warm, eat well or keep active and/or reduce isolation. Grants of up to £5,000. Standard Sussex Community Foundation application form.

Westdene Fund Supports individual young people (16-25 years) in Sussex with outstanding musical talent. Grants of up to £1000. Separate guidance and application form.

William Alexander Fund Gives grants to groups in Brighton & Hove who support: disadvantaged children & young people, the elderly, refugees & asylum seekers, those who suffer from drug & alcohol misuse or people suffering with mental health issues. Grants of up to £5,000. Standard Sussex Community Foundation application form.

William Reed Fund Grants to local or national organisations supporting social welfare projects operating and benefiting people in the Crawley area. Grants of up to £5,000. Standard Sussex Community Foundation application form.
